- Construction and engineering on Keith Hollow Road, Barr Township.
- Paving two roads and three streets, Gulich Township.
- Paving streets, Houtzdale Borough.
- Reconstruction of Firehouse Road, Cooper Township.
- Reconstruction of Sington Road, Graham Township
- Reconstruction and repaving Lingle Street and Stone Street Extension, Osceola Mills Borough.
- Repair and repaving Cemetery Road, Morris Township.
- Repaving Hollow Road, Decatur Township.
- Resurfacing Grange Avenue and Alexander Lane, Woodward Township.
- Street rehabilitation, Westover Borough.
